Our City borders multiple other municipalities and jurisdictions, which are interconnected with the remaining 80-90 specifically identifiable areas within St. Louis County. Transient motorists are a commonality on the state, county, and municipal roadway systems within our City making it a major crossroads that is consistently accessed by non-residents. During this period, Non-Resident Stops represented approximately 82% of the total vehicle stops in our City (Table 1). The Location of Stop is primarily on County roadways at a total rate of 65%. County roadways are the major thoroughfares used to pass through our jurisdiction by non-residents (Table 4). This belief is also supported by Table 2, whereas 82% of the total stops (White 95%, Black 81%, Hispanic 100%, and Other 95%) were not residents of the City at the time of the stop. Information gathered on resident, race, gender, and age status may be misrepresented by the driver at the time of the stop. The data does not include measurable information such as 1) the volume of total non-resident motorists that were not stopped during this period, 2) the volume of individual ethnic, gender, and age groups among the volume of the total non-resident motorist group and 3) the exclusion of motorists who do not have a driver's license which implies that every individual age 16+ has a driver's license and drives a vehicle. This also excludes individuals between ages 15 and 16 that are permitted by law to obtain a driver's license permit to drive a vehicle. The Vehicle Stops Report is open to extremely broad and very shallow conclusions as the interpretations of the outcomes provided cannot give rise to any legitimate and credible argument of such since this can neither be proven or disproven. The margin for error in the report has a high probability for

misrepresentation in its findings.

The City of Blue Springs is in The Kansas City Metropolitan area along Interstate 70 and US 40 Highways. This route is heavily traveled between Kansas City and St. Louis with both in State and out of State travelers. Within the City, and near the Interstate 70 corridor, are many restaurants and retail businesses to include a large shopping complex at Interstate 70 and Adams Dairy Parkway. In addition, the Blue Springs School District attracts a large number of students and visitors who are not actual residents of the City. These daily travelers greatly affect the population levels outside of those reflected in the State population estimates of drivers 16 and over, which in turn has an impact on the disparity index.

The City of Blue Springs has made a strong commitment to protect citizens, both residents and non-residents, from racially motivated or bias based profiling. In addition to the mandatory annual Racial Profiling training required by the State of Missouri, the members of the Blue Springs Police Department, both sworn and civilian, have been given additional POST certified training in this area.

The population estimate used to analyze the 2022 Boone County Sheriff's Office's traffic stop data was 149,127, while the U.S. Census Bureau estimated Boone County's population to be 187,690 in 2022.

Boone County is a regional employment hub in mid-Missouri and home to numerous college campuses, numerous hospitals, clinics, businesses, sporting events, and entertainment venues. Visitors are drawn to Boone County resulting in temporary population increases at various times throughout each year. Boone County also has the convergence



of two major highways (Interstate 70 & U.S. Highway 63).

In 2022, 91% of the time deputies didn't know the driver's race prior to the traffic stop and approximately 30% of drivers stopped were non-residents. The US Census Bureau reports the demographic makeup by race in Boone County very differently than what was used for the benchmark to figure the disparity index by race. For example, the US Census Bureau indicates the following percentages for each race and the percentage used to compute the disparity index is in parenthesis: White alone – 78.0% (82.08%); Black or African American alone – 10.0% (8.53%); Hispanic or Latino – 3.7% (3.16%); American Indian and Alaska Native alone – 0.5% (0.24% for only Native American); Asian alone – 5.0% (4.69%). Finally, 3.5% of Boone County's population identify as "Two or More Races" and may appear to be a part of any race listed.

Racial disparity based on raw traffic stop data in comparison to the local population is not indicative of any underlying issues absent consideration of other socio-economic factors. As a CALEA accredited agency, we continually train our staff on unbiased policing and recognizing bias. We also continually evaluate enforcement activities, disparity numbers, and complaints to identify potential areas for improvement.

A large portion of our agency's traffic stops occur on Hwy. 171 which is a major highway connecting Southeast Kansas and Southwest Missouri, Hwy. 49 to Arkansas, and Hwy. 71 to Kansas City. It also provides the main road between Pittsburg State University in Kansas to Joplin, Missouri. This also makes it a popular corridor for drug transportation between the states. Also, I believe there is an assumption that the officers know the race of the driver of the vehicle before it is stopped in your data collection. The truth is there is an average 13.5 hours of daylight during the year, it is very difficult, if not impossible to tell the race of drivers during night time hours, and it is my observation that it is not always possible to determine the race of a driver before a traffic stop during daylight hours. There is a 'time of stop" space on the traffic stop data sheet, but it is not asked for on the report. Due to this corridor, and the amount of our traffic stops on that roadway, there is a much larger range and percentage of all races/ethnicities passing through that is not reflected in our city population. I believe that due to this, it skews our VSR report when looking at our population statistics only.

Gladstone is considered an "inner tier" suburb in the Kansas City Metropolitan Statistical Area. It is completely surrounded by Kansas City, MO, a densely populated urban center with significantly different demographics than Gladstone. Kansas City's white population is approximately 60% as opposed to Gladstone's 84% white population. While Gladstone is primarily residential, it does have vibrant and active retail areas. These retail districts include big box stores such as Walmart and Home Depot in addition to grocery stores and other retail businesses. Because of these districts and the overall location of Gladstone, there are multiple thoroughfares and arterial roads running through the city. These roads are used by many residents of surrounding municipalities to connect to the multiple state and interstate highways that run just outside of Gladstone's city limits in addition to patronizing our businesses. When viewed from that context, it appears that at any one time, the majority of people operating vehicles inside the corporate city limits of Gladstone are not its residents. As demonstrated by submitted statistics, approximately 73% of the stops conducted by our officers are on vehicles operated by non-residents of the driving age population using your 2021 population statistic. Since the numbers clearly show the vast majority of individuals contacted

by Gladstone officers during vehicle stops are not residents, comparing the demographics of these drivers to the demographics of Gladstone's residents will result in flawed conclusions. Finally, as a CALEA nationally accredited organization, the Gladstone Police Department is continuously providing training to its members on such topics as bias-based policing and legal updates to ensure a well-trained, professional police force utilizing best practices in our profession.

Independence is the fifth-largest city in Missouri, county seat and immediate suburb of Kansas City, with a population of 117,217. Ten major Interstates, highways and roadways allow direct access to the multiple racially diverse Kansas City metropolitan attractions located in the community; Harry S. Truman Presidential Library and historic home, Silverstein Eye Centers Arena , Super-Regional Independence Center Shopping Mall (2nd largest in KC Metro area with approximately 12 million annual visitors), 39th Street retail area, AMC 20 movie theater complex, Chrysler Baseball Stadium, Community of Christ International Headquarters, colleges, community festivals, and multi-cultural dining venues. For 2022, Resident stops were 6,582. . . Non-Resident stops were 7,268 for a total stops of 13,850. So, this was over 50% that were nonresidents. Significant traffic safety efforts are conducted along the major roadways and additional funding is provided for enforcement through state funded Hazardous Moving Violation grants, DWI Enforcement grants and Occupant Protection grants.

Due to the reduced manpower, modified COVID schedules, and modified COVID work/activity procedures significantly impacted 2020 and 2021's data the 2022 data is compared to 2019 as this is a more accurate representation rather than the previous two years. City of Independence, 2022 disparity index for black, Hispanic and Asian drivers dropped after remaining fairly consistent over the previous five years. Black driver disproportions dropped from 3.63 in 2019 to 2.5 in 2022. The metropolitan attractions and thirty-one low income housing apartment complexes have influenced the racial composition of the motoring public to the community. The Independence Police Department is a professional law enforcement organization that is committed to impartial, competent, and courteous service to the public without regard to race, creed or gender. Officers receive annual training on cultural challenges and issues by ensuring and maintaining accountability in part through the integrity of the racial profiling documentation process in compliance with Missouri State Statute.

Disparity indexes have not fluctuated significantly since the data collection began in 2000. However, these numbers should be interpreted cautiously. Specifically, relying on a census population for ages 16 and over as a benchmark does not provide a realistic picture of the driving population in Kansas City, Missouri at any given time. There are several major thoroughfares that run through the City, including I-29, I-35, and I-70 that contain a large percentage of drivers not reflected in the static estimated census population used for comparison purposes. Additionally, Kansas City is contained within a metropolitan population of approximately 2.1 million, which adds to the commuter population on these roadways. When examining search rates, the probable cause/authority to search reasons should be considered. When examining arrest rates, the arrest charges should be considered. Lastly, KCPD views vehicle stop data collection as one of many tools to address the issue of racial profiling. Other tools in use by the Department include training, community programs, and policies.

Kirksville is home to two major universities whose enrollment data is not totally reflected in the census figure. Truman State University has 455 (11.5%) students listed other than white. They also have an additional 293 (7.4%) International students according to the 2022-2023 enrollment statistics. ATSU enrollment for the fall of 2022 has 315 (46%) students listed as non-white. The majority of ATSU students, 99% come from outside of the Kirksville area. The City of Kirksville has seen a significant increase of families from the Democratic Republic of the Congo in recent years. As an example, the Kirksville RIII School District reports 403 students identifying as non-white enrolled in K12 for the 2022-2023 school year. Kirksville is located on one of the few major north-south highways (Highway 63) that services northern Missouri and southern Iowa. Kirksville is the largest city for miles and is the cultural/economic hub for a very large area. This explains some of the daily diversity of Kirksville and of those not counted in the city's census information.

The population "estimates" traditionally used in the Vehicle Stop Report (VSR) are not a true reflection of the racial diversity represented in Ladue on any given day and do not take into consideration the population of the surrounding area. As stated in the Attorney General's report, "the Disparity Index is highly problematic because: i) it is sensitive to the choice of the benchmark population; ii) as a ratio, it is affected by changes in both the numerator and denominator; and iii) it is not meaningful to compare the Disparity Index across communities with different percentages of minority populations."

Ladue is home to several major thoroughfares, which are used to connect Ladue to people from all over St. Louis City, St. Louis County, and throughout Missouri. I-170 and US 64/40 both travel through Ladue, along with

several city streets which all carry tens of thousands of vehicles through Ladue daily. The transitory population is far contrasting to the residential population and is more reflective of the demographics of this State and St. Louis County.

Our concern is that the residential data used in the VSR varies greatly and does not provide an accurate account of the diverse transitory population that truly represents the diversity within the City of Ladue at any given time. Simply using St. Louis County, the State of Missouri, or any surrounding jurisdiction's population percentages would drastically change the outlook of the Disparity Index and would more accurately reflect our department's continued commitment to fair and impartial policing.

The city of Lake Saint Louis is bordered by I-70 to the north and I-64 bisects the south end with a recent addition of Hwy 364 as a new connector highway throughout St. Charles County. A large shopping center is just north of I-64 and a retail district lies directly to the south. Workers routinely travel both interstate corridors west to the Wentzville GM Plant and to major employers in O'Fallon and other points east. Additionally, the population of our city is greater than indicated from the 2020 census results. As of 2020, the population of the city shows 16,864. The rapid growth of Lee's Summit is outpacing the ability of census data to track the City's population of all demographics. As a local example, the data underrepresents the diversity of the population, reporting 7.85% African American residents while the school district reports 12.6% of students are African American, almost a 5% difference. Lee's Summit is also a retail, education and employment destination, attracting residents from adjacent urban centers with higher minority population percentages (25 – 40%) not reflected in the population data. The driving population statistics reflect traffic on major arterial roadways, such as I-470, M-291, US-50, and M-150. This through traffic is illustrated by the fact that over half of all individuals stopped are non-residents. The highest statistically significant search rate indicates African Americans are searched at a factor of 3.56, but this includes 148 "searches" mandated incident to or inventory due to arrest or the seizure of contraband in plain view. Only ten searches were based upon consent, along with 32 for reasonable suspicion (smell of alcohol or drugs or suspicion of a weapon) out of 3,849 traffic stops, or 1%. The police department continues to select, hire and train a diverse workforce to reduce the potential

for bias in policing.

It should be noted that 70% of all 2022 traffic stops by Platte County personnel, were reported as nonresident drivers. The disparity index is based upon the population demographics of the City of Town & Country, which has a current population of 11,640 (disparity index only indicates 9509) with an African American population of .9% (US Census Bureau). This does not accurately reflect the demographics of the true motoring population through the City daily. Every weekday, nearly 415,000 motorists travel through our city on the 2nd most voluminous interchange in the State (Interstates 64/40/270). Our motoring public is more reflective of the demographics of the State and St. Louis County, which are comprised of African American populations of 11.4% and 24.2% respectively (US Census Bureau). The stop data for Town & Country Police indicate over 71% of stops occurred on either the interstates, US Highway

or State Highway, of which, 83% were initiated for hazardous moving violations. Overall, only 23% of the stops were African American drivers. The natural implication of this statistic is that the ratio of the race of motorists stopped for violations would reflect state and county demographics, not the residential population of the City of Town & Country.
