FELONY COMPLAINT

COUNT I

Promoting Gambling in the First Degree
Charge Code: 572.030-001Y20203911.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 572.030, RSMo, committed the class E felony of promoting gambling in the first degree, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about April 14, 2026, in the County of Boone, State of Missouri, the defendant knowingly advanced or profited from unlawful gambling activity by setting up and operating a slot machine at Boone County Eagle Stop.

RANGE OF PUNISHMENT

COUNTS I-IV: The range punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.
