- 2. All emails sent or received by Board of Education Member Joy Hawks between September 1, 2021 and November 15, 2021 containing the terms "NSBA," "Garland," or "FBI".

I request these records in an electronic format if that format is available.

These requests seek documents that are in the public interest because they are likely to contribute to a better understanding of the operations or activities of Union R-XI School District. In addition, this is not a request for commercial purposes. For these reasons, pursuant to § 610.026.1(1), RSMo, the Missouri Attorney General's Office requests a waiver of any fees associated with processing this request for records. If that waiver is not granted, please provide an estimate of the cost.

Request to speak to the R-V School Board at their next regular board meeting on September 8, 2021.

I would like to discuss, for consideration by the Board, amending Board Policy BDDB-2: AGENDAS to add a tentative agenda to be released to the public in advance of the 5 day requirement to speak to the board.

In the public forum, several board members expressed their desire for the public to become more involved in other school matters. However, due to the constraints of the board's practice of not displaying the tentative agenda until after the timeframe of requiring someone to submit a request, it makes it very difficult to address the board regarding issues they are discussing. As demonstrated in its August 11' 2021 meeting the Board has not shown it willingness to exercise its right to "waive formalities in emergency situations" as per Policy BDDH-2: PUBLIC PARTICIPATION AT BOARD MEETINGS. Or exercise its right to modify the agenda by motion prior to approval as per Policy BDDB-2: AGENDAS. Therefore participation by the public is extremely limited due to lack of knowledge of what the board will be discussing at their meeting prior to the 5 day requirement in requesting to speak. There is no currently listed Board Policy regarding release of the agenda. The only listed policy is that the tentative agenda has to be mailed to the board members 4 days in advance of the scheduled meeting as listed in Policy BDDB-2: AGENDAS.

MSBA has two sample policies. One allows for time to be set aside during regular meetings where members of the public can comment on agenda items, as well as the opportunity for a patron to request an item to be put on the agenda (see attached.) The other is the one your Board has adopted, which only allows patrons to request that an item is put on the agenda. In MSBA's position, both are acceptable ways of doing business.

I think the disconnect is that many think that the ONLY way to communicate with the Board about an agenda item is to physically come to a school board meeting and speak. But in reality, there are other ways to communicate with the Board as a whole that are actually more convenient for the public (send communications to the Board Secretary addressed to the whole board, e-mail the board) and in fact many districts are exploring additional methods like having a designated e-mail or other electronic communication that is automatically forwarded to the Board, creating coffees and other opportunities for discussion, including more community members on committees, etc. One way to address the concern might be to consider the existing methods for members of the public to communicate to the Board and whether those should be better advertised or expanded.

Another way to address this would be to shorten the amount of time for the public to get on the agenda to say 3 days, instead of 5. But the intent of "getting on the agenda" is actually to bring a new item to the Board's attention, not merely speak on something already on the agenda. And the purpose of the 5-day window is to allow the administration to look into whatever the concern is and round up the appropriate information or people to be at the meeting and to make sure the issue is properly posted on the final agenda. You might not want to shortcut the timeframe - particularly when the true intent seems to be to allow for comment on something that is already on the agenda.

What I really think this person wants is for the Board to create a public comment period at each regular meeting where members of the public can come speak on something that is already on the agenda. Many districts have this. It is not required by law and there are pros and cons to it. Obviously it shows that the Board is welcome to hear from patrons. But these sessions are not perfect. They can lengthen school board meetings, so most districts put time limits on the speakers (3-5 minutes) and the overall comment session (20-30minutes). That means not everyone who wants to speak always gets to speak, because the Board needs to get other business done. It also means that the Board does not get a true understanding of all views because there is not enough time to hear everyone and not everyone is motivated or has time to physically come to a Board meeting.

So the real issue is - what is the best way to solicit input from the community on any given issue? Also, is there an appearance to the community that the Board is not interested in community input or is not responsive to it? I wish I knew the answers to this! And it probably depends on your community. But this is what many districts are struggling with. I personally would not jump into having public comment at Board meetings if you have not done so in the past. If you do, put some strict parameters on it so that it does not interfere with getting business done and certainly do not let that be the only way the public can communicate. The reality is only the very upset show up at Board meetings, it seems. But I refuse to believe that everyone in the universe is angry. We need a good way of sorting out what the community thinks without just listening to the loudest.


