### AMENDED FELONY COMPLAINT

COMES NOW the Attorney General for the State of Missouri, and states the following:

#### COUNT I

Charge Code: 565.020-001Y20200907.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.020, RSMo, committed the class A felony of murder in the first degree punishable upon conviction under Section 565.020, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant after deliberation, knowingly caused the death of by shooting him, and that the defendant was eighteen years of age or older at the time of the offense.

#### COUNT II

# Charge Code: 571.015-001Y20205299.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant committed the felony of murder in the first degree charged in Count 1, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of murder in the first degree by, with or through, the knowing use, assistance or aid of a deadly weapon, namely a Smith & Wesson .40 caliber handgun, and at that time, the defendant knowingly possessed said firearm, and on or about November 14, 2006, a date preceding the instant offense, the defendant was convicted of the felonies of tampering with a motor vehicle and property damage 1<sup>st</sup> degree in the 12th Judicial Circuit Court of Warren County of the State of Missouri, cause no. 06BB-CR00308-01.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

### COUNT III Charge Code: 565.050-001Y20201304.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.050, RSMo, committed the class A felony of assault in the first degree, punishable upon conviction under Section 558.011, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant knowingly caused serious physical injury to **Exercise 10** by shooting him.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

### COUNT IV Charge Code: 571.015-001Y20205299.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant committed the felony of assault in the first degree charged in Count 3, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of assault in the first degree by, with or through, the knowing use, assistance or aid of a deadly weapon, namely a Smith & Wesson .40 caliber handgun, and at that time, the defendant knowingly possessed said firearm, and on or about November 14, 2006, a date preceding the instant offense, the defendant was convicted of the felonies of tampering with a motor vehicle and property damage 1<sup>st</sup> degree in the 12th Judicial Circuit Court of Warren County of the State of Missouri, cause no. 06BB-CR00308-01.

An individual convicted and sentenced for this offense shall not be eligible for parole until eighty-five percent of the sentence is served.

### COUNT V Charge Code: 571.070-001Y20205212.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.070, RSMo, committed the class D felony of unlawful possession of a firearm, punishable under Sections 558.002 and 558.011, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant knowingly possessed a Smith & Wesson .40 caliber handgun, a firearm, and on or about November 14, 2006, the defendant was convicted of the felonies of tampering with a motor vehicle and property damage 1<sup>st</sup> degree in the 12th Judicial Circuit Court of Warren County of the State of Missouri, cause no. 06BB-CR00308-01.

# COUNT VI Charge Code: 571.070-001Y20205212.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.070, RSMo, committed the class D felony of unlawful possession of a firearm, punishable under Sections 558.002 and 558.011, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant knowingly possessed a 12 gauge shotgun, a firearm, and on or about November 14, 2006, the defendant was convicted of the felonies of tampering with a motor vehicle and property damage 1<sup>st</sup> degree in the 12th Judicial Circuit Court of Warren County of the State of Missouri, cause no. 06BB-CR00308-01.

#### COUNT VII

#### Charge Code: 571.020-001Y20205203.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.020.1, RSMo, committed the class D felony of unlawful possession of a weapon, punishable upon conviction under Sections 558.011 and 558.002, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant knowingly possessed a short barreled shotgun.

### COUNT VIII Charge Code: 579.015-001Y20203599.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation of Section 579.015, RSMo, committed the class D felony of possession of a controlled substance, punishable upon conviction under Section(s) 558.002 and 558.011, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, the defendant knowingly possessed methamphetamine, a controlled substance, knowing of its presence and nature.

# COUNT IX Charge Code: 575.150-001Y20204801.0

The Attorney General for the State of Missouri, upon information and belief, charges that the defendant, in violation Section 575.150, RSMo, committed the class E felony of resisting an arrest, punishable upon conviction under Sections 558.002 and 558.011, RSMo, in that on or about March 12, 2023, in the County of Gasconade, State of Missouri, **March** and **March**, law enforcement officers, were making an arrest of defendant for felony offenses, and the defendant knew or reasonably should have known that the officers were making an arrest, and, for the purpose of preventing the officers from effecting the arrest, resisted the arrest of defendant by fleeing from the officers and using or threatening the use of violence or physical force and defendant fled in such a manner that created a substantial risk of serious physical injury or death to a person in that defendant shot a firearm in an occupied building.

# **PRIOR & PERSISTENT OFFENDER**

That Defendant Kenneth Simpson is a prior offender under Section 558.016, RSMo. Defendant is also a persistent offender and is punishable by sentence to an extended term of imprisonment under Sections 558.016 and 557.036, RSMo, in that he has pleaded guilty to two or more felonies committed at different times. The felonies are as follows:

- 1. On or about October 4, 2004, Defendant was found guilty of eleven different felonies of tampering with a motor vehicle, for conduct occurring on or about March 16, 2004, cause no. 04A8-CR00713-01, in the 12<sup>th</sup> Judicial Circuit Court of Warren County, State of Missouri; and
- On or about April 7, 2005, Defendant was found guilty of the felony of tampering with a motor vehicle, for conduct occurring on or about December 29, 2004, cause no. 05A8-CR00022-01, in the 12<sup>th</sup> Judicial Circuit Court of Warren County, State of Missouri; and
- On or about November 14, 2006, Defendant was found guilty of the felonies of property damage first degree and tampering with a motor vehicle, for conduct occurring on or about March 14, 2006, cause no. 06BB-CR00308-01, in the 12<sup>th</sup> Judicial Circuit Court of Warren County, State of Missouri.

The facts that form the basis for this information and belief are contained in the statement(s) of facts filed contemporaneously herewith, made a part hereof, and submitted as a basis upon which this court may find the existence of probable cause. WHEREFORE, the Attorney General prays that an arrest warrant be issued as provided by law.

### **RANGE OF PUNISHMENT**

#### COUNT I:

If a person is eighteen years of age or older at the time of the offense, the punishment for murder in the first degree shall be either death or imprisonment for life without eligibility for probation or parole, or release except by act of the governor.

### COUNTS II & IV:

The range of punishment for a first offense under this section is a term of imprisonment in the Missouri Department of Corrections of no less than three (3) years, but not to exceed fifteen (15) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three (3) calendar years. The range of punishment for a first offense under this section, while unlawfully possessing a firearm, is a term of imprisonment in the Missouri Department of Corrections of no less than five (5) years, but not to exceed fifteen (15) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of three (3) calendar years. The range of punishment for a second offense under this section is a term of imprisonment in the Missouri Department of Corrections of no less than five (5) years, but not to exceed thirty (30) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of five (5) calendar years. The range of punishment for a second offense under this section, while unlawfully possessing a firearm, is a term of imprisonment in the Missouri Department of Corrections of no less than fifteen (15) years, but not to exceed thirty (30) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of five (5) calendar years. The range of punishment for a

third offense under this section is a term of imprisonment in the Missouri Department of Corrections of no less than ten (10) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument or deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of ten (10) calendar years. The range of punishment for a third offense under this section, while unlawfully possessing a firearm, is a term of imprisonment in the Missouri Department of Corrections of no less than fifteen (15) years, to be served in addition to and consecutive to any punishment provided by law for a crime committed by, with, or through the use, assistance, or aid of a dangerous instrument of deadly weapon. No person convicted under this section shall be eligible for parole, probation, conditional release, or suspended imposition or execution of sentence for a period of ten (10) calendar years.

# COUNT III:

The range of punishment for a class A felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than ten (10) years and not to exceed thirty (30) years, or life imprisonment.

# COUNTS V, VI, VII, & VIII:

The range punishment for a class D felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed seven (7) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.

# COUNT IX:

The range punishment for a class E felony is imprisonment in the custody of the Missouri Department of Corrections for a term of years not less than one (1) year and not to exceed four (4) years; or by imprisonment for a special term not to exceed one (1) year in the county jail or other authorized penal institution; or by a fine not to exceed ten thousand dollars (\$10,000); or by both imprisonment and a fine. If money or property has been gained through the commission of the crime, any fine imposed may be not more than double the amount of the offender's gain from the commission of the crime.
