I write to request copies of the following public records pursuant to Chapter 610 of the Missouri Revised Statutes:


1. List maintained by the District of all instructional textbooks adopted for use in K – 5 classrooms during the past ten (10) years.

These requests seek documents that are in the public interest because they are likely to contribute to a better understanding of the operations or activities of Warrensburg R-VI School District. In addition, this is not a request for commercial purposes. For these reasons, pursuant to § 610.026.1(1), RSMo, the Missouri Attorney General's Office requests a waiver of any fees associated with processing this request for records.

Thank you for your time and attention to this matter.

Due to the nature and volume of the documents requested and the time it will require to search for, collect, and copy the documents that may be responsive to your request, the District will be unable to respond within the three (3) business days generally provided pursuant to Section 610.023 of the Missouri Revised Statutes. Specifically, the ten-year period will require manual review of textbook lists used in individual classrooms in all of the elementary schools in the district. Additionally, as you are aware, the end of the school year is an extremely busy time for the administration, faculty, and support staff, who will be involved in responding to your request. This is due to end of school activities in all grade levels and at the administrative level. Therefore, in accordance with the provisions of Section 610.023(3), this letter will serve as a detailed explanation of the cause for delay in providing the requested records. Nevertheless, you

may be assured that any records that are subject to disclosure and are available will be provided to you as soon as reasonably possible.

Finally, the District will waive the fees associated with this request. We anticipate that we will be able to provide a response by Wednesday, June 1, 2022. We will notify you if it is necessary to extend that deadline.
